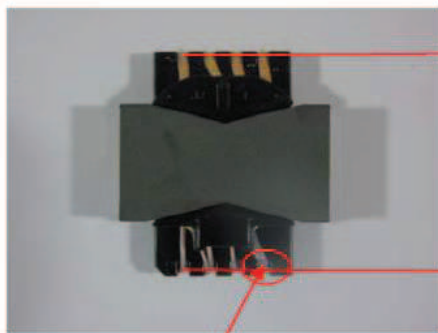

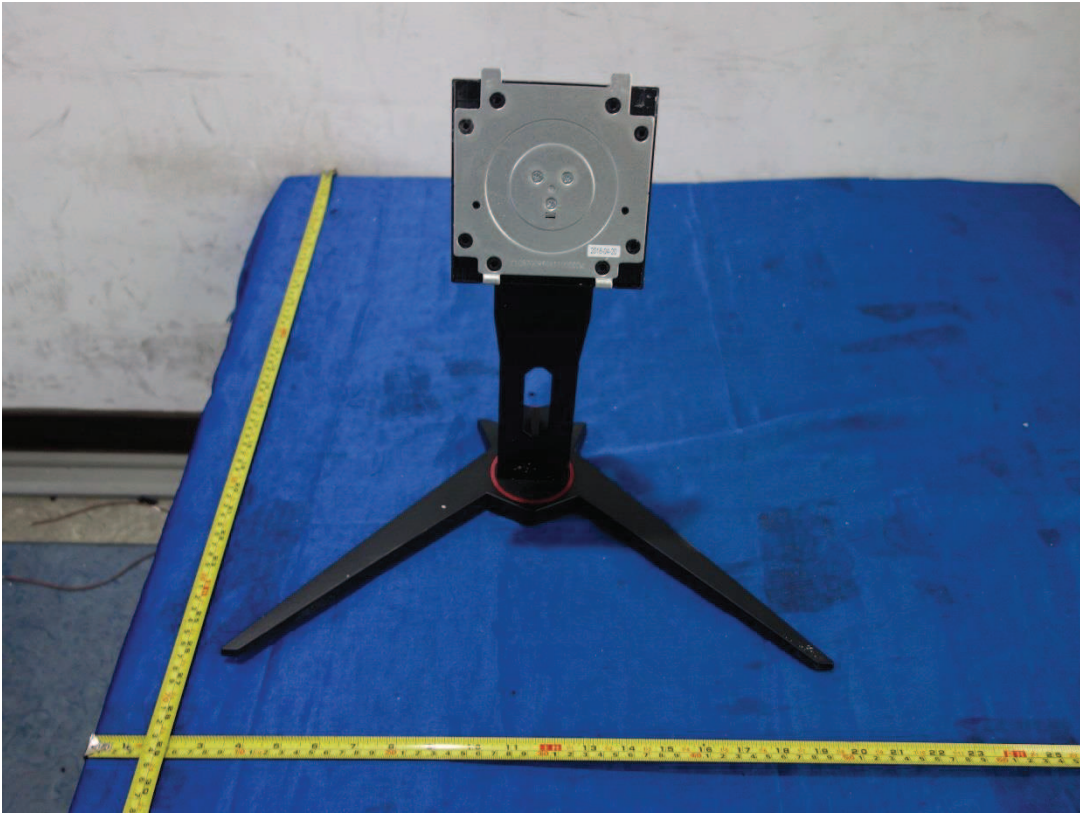


Figure 3. Stand base

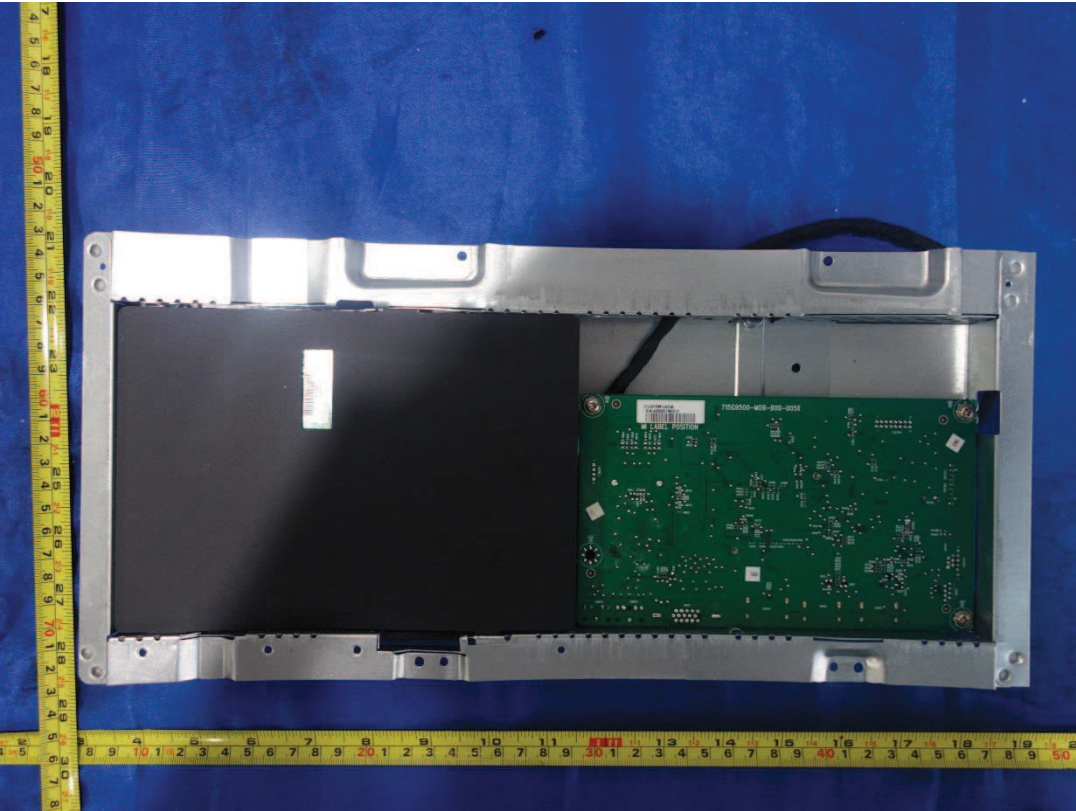


Figure 7. Internal view of Metal enclosure

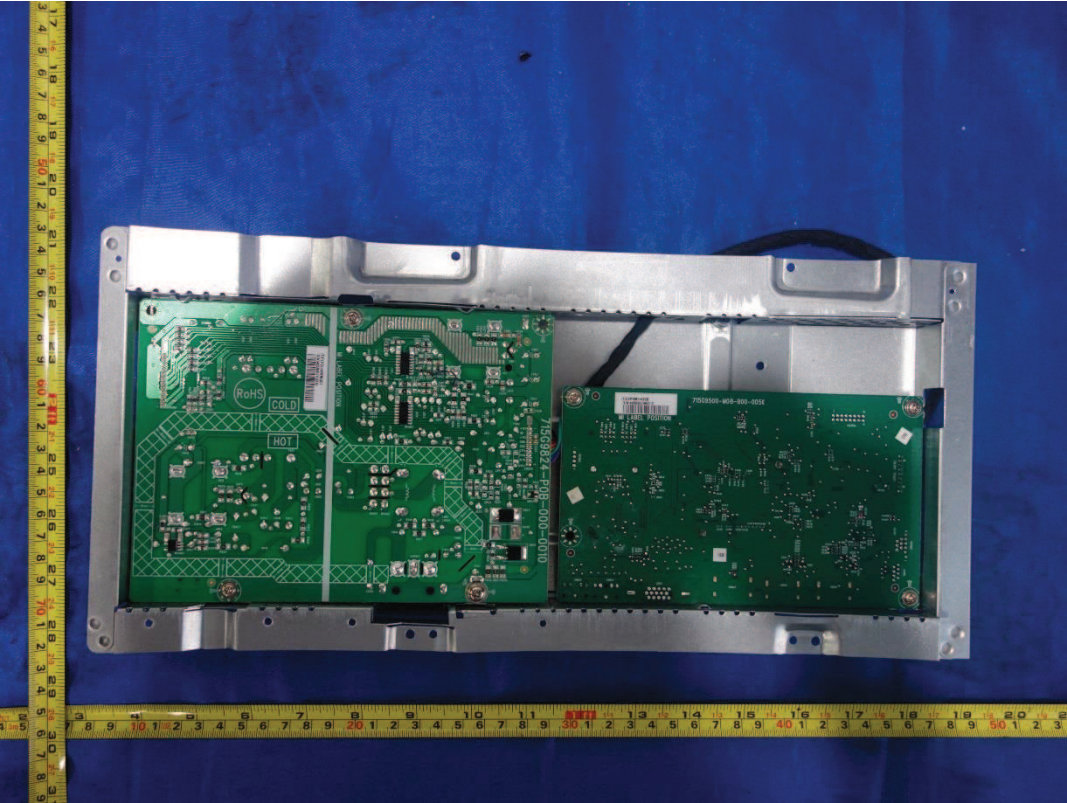


Figure 8. Internal view of Metal enclosure

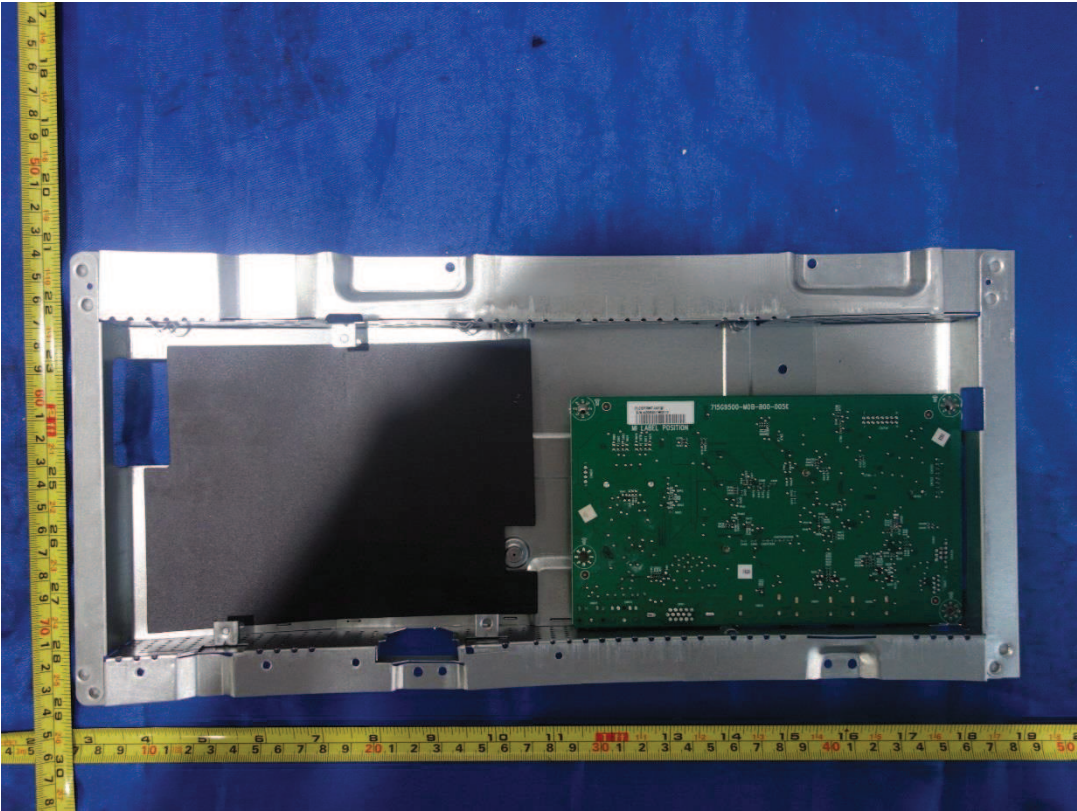


Figure 9. Internal view of Metal enclosure

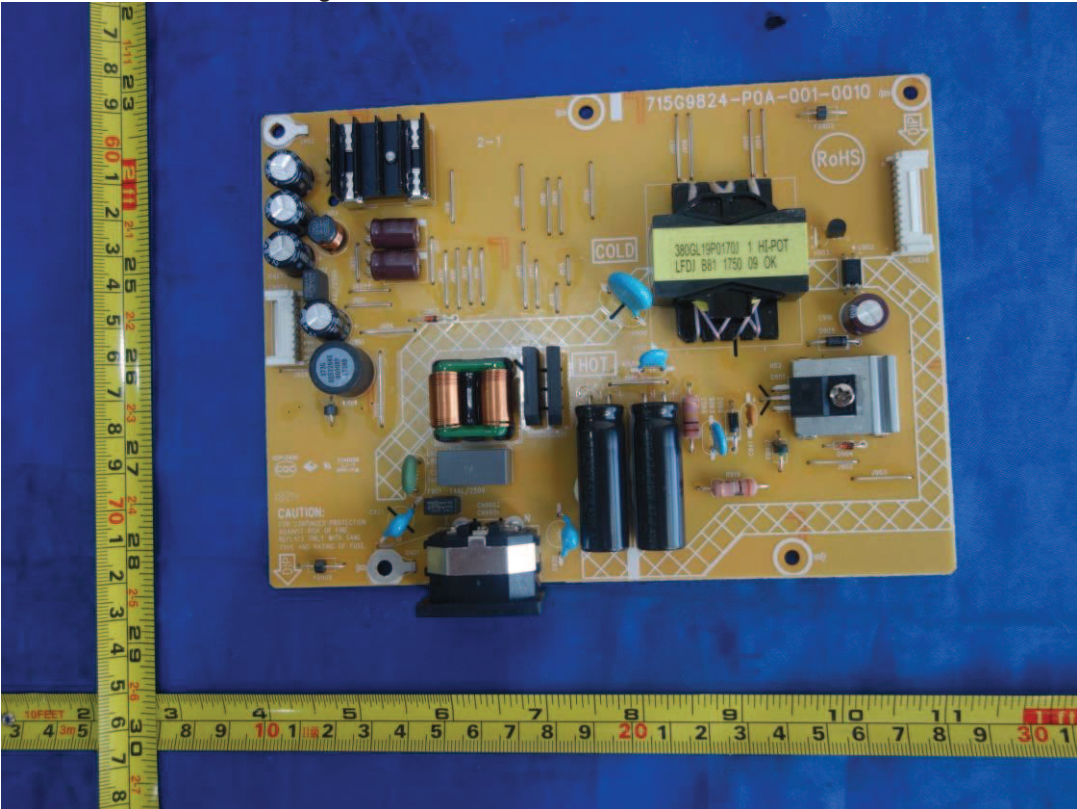


Figure 10. Power board 715G9824

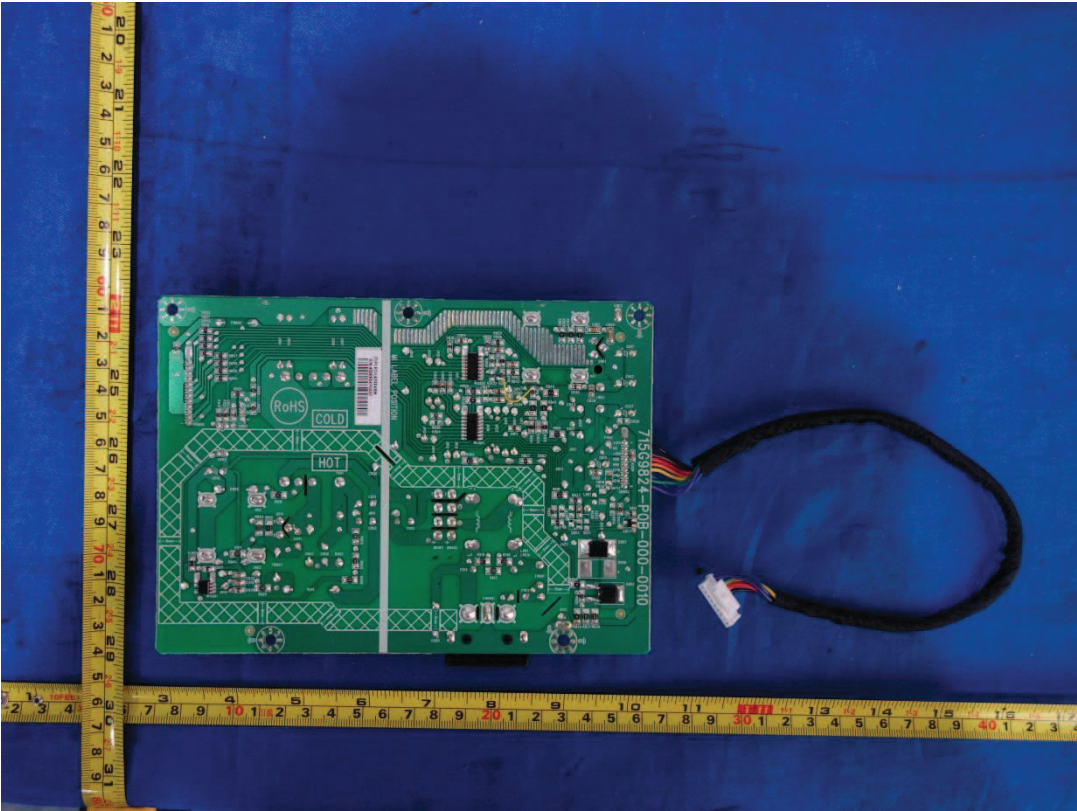


Figure 11. Power board 715G9824

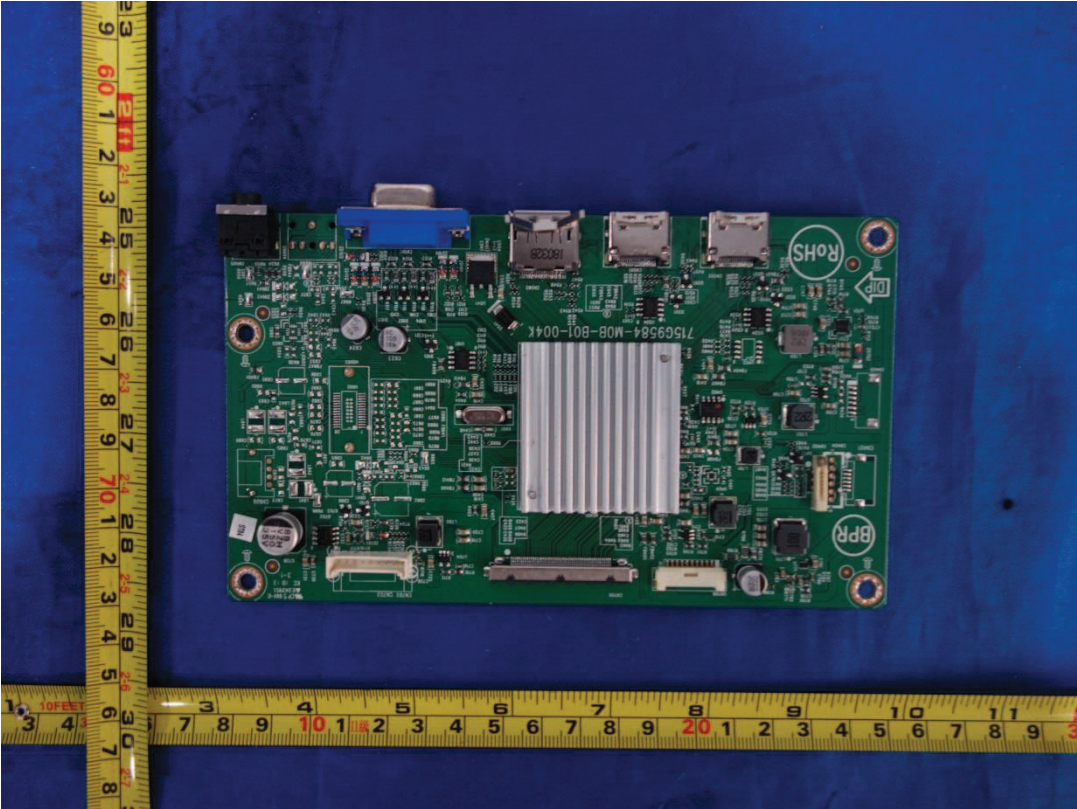


Figure 12. Main board 715G9584

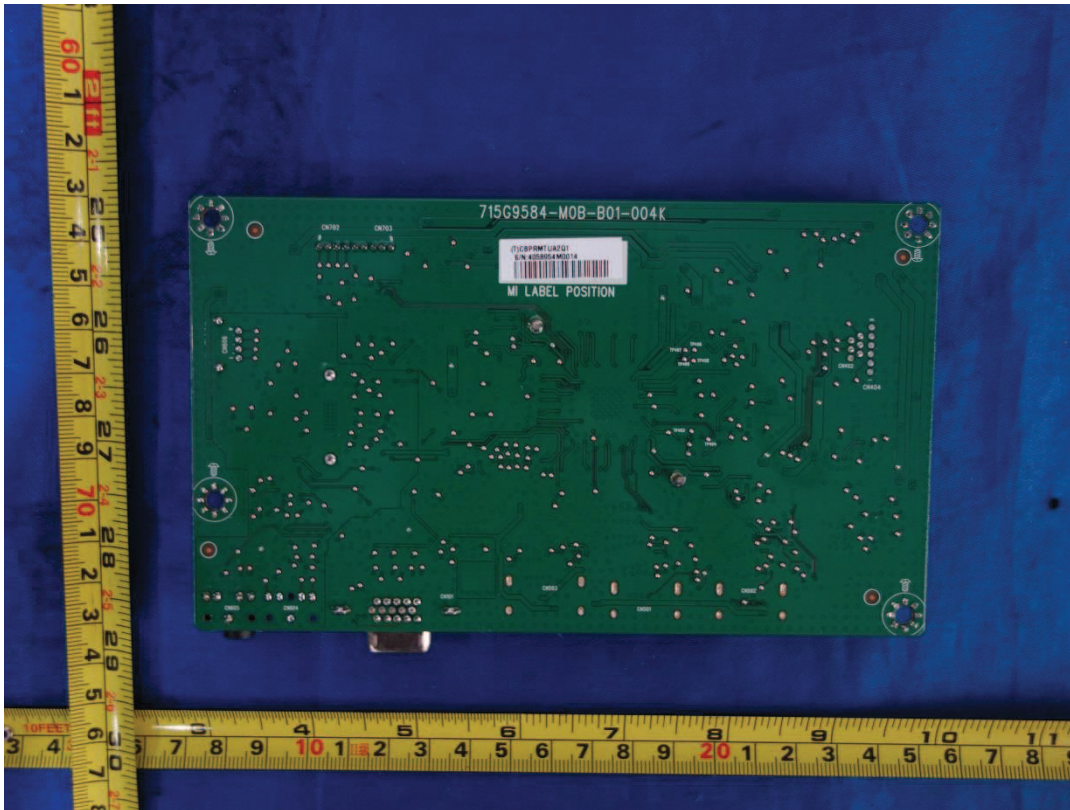


Figure 13. Main board 715G9584

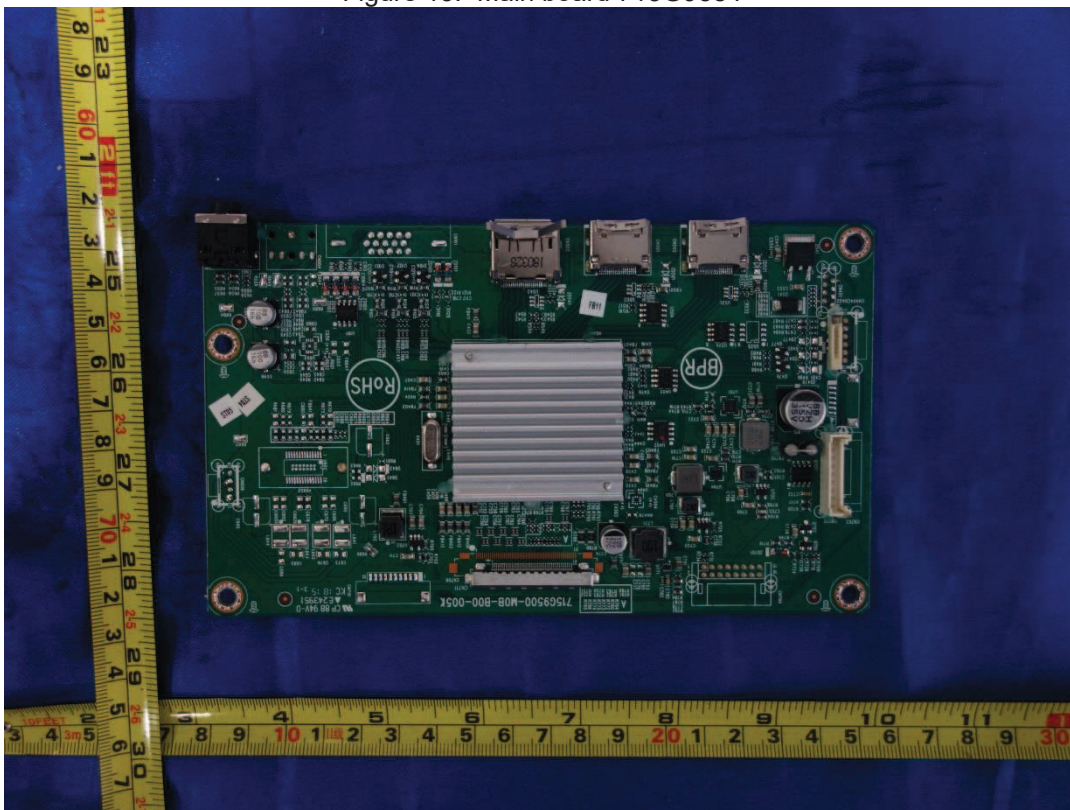


Figure 14. Main board 715G9500

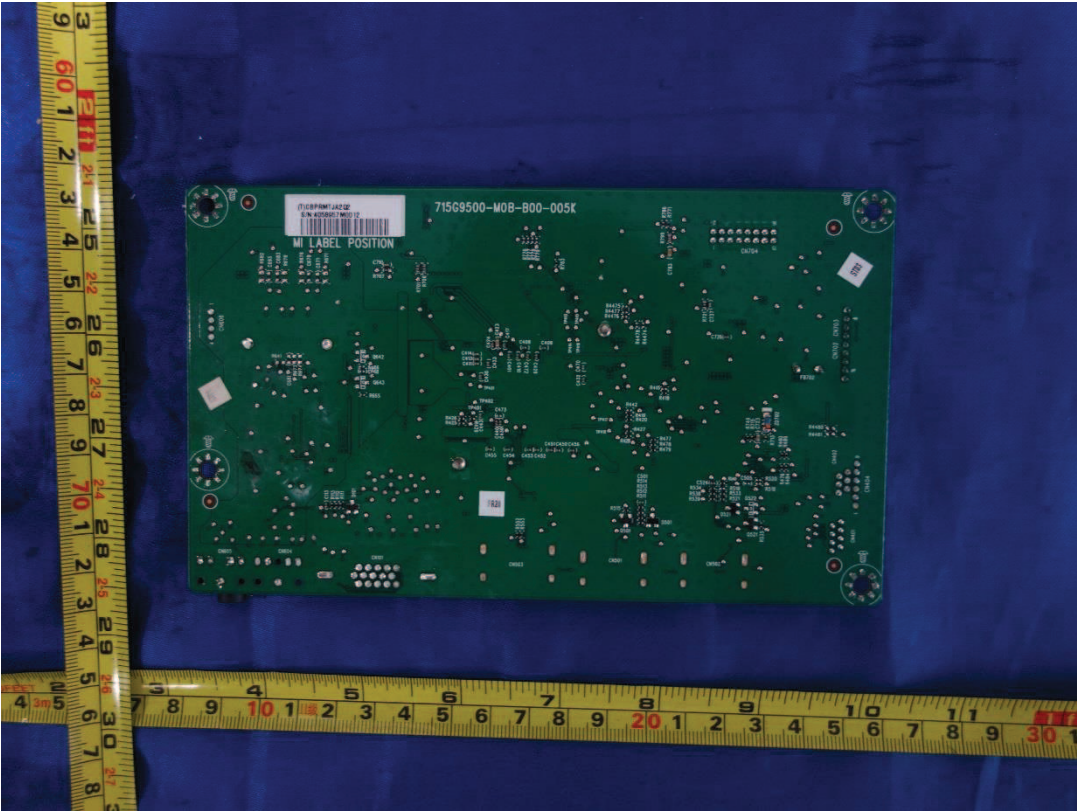


Figure 15. Main board 715G9500
