
3.3 EUT OPERATING CONDITIONS

The EUT exercise program used during radiated and/or conducted emission measurement was designed to exercise the various system components in a manner similar to a typical use. The standard test signals and output signal as following:

- 1. EUT Connected to Earphone via Earphone cable.
- 2. EUT Connected to PC via D-SUB & HDMI & Display & DVI & USB & Audio cable.
- 3. EUT Connected to HDD via USB cable.

As the keyboard and mouse are strictly input devices, no data is transmitted to (from) them during test. They are, however, continuously scanned for data input activity.

4.1.3 TEST PROCEDURE

- a. The measuring distance of 10 m shall be used for measurements. The EUT was placed on the top of a rotating table 0.8 meter above the ground at a 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(below 1GHz).

- d. The initial step in collecting radiated emission data is a receiver peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.
- e. All readings are Peak unless otherwise stated QP in column of Note. Peak denotes that the Peak reading compliance with the QP Limits and then QP Mode measurement didn't perform. (below 1GHz)





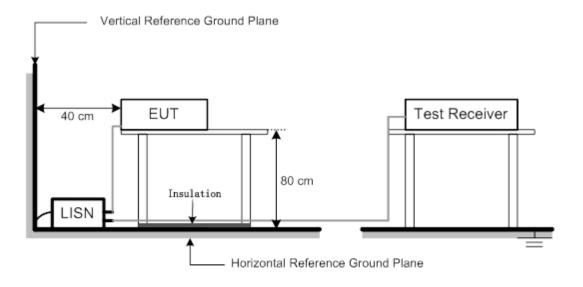
4.2.3 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.






Figure C.1 - Measurement distance




Figure C.2 - Boundary of EUT, Local AE and associated cabling



Radiated emissions up to 1 GHz
















Immunity to conducted disturbances, induced by radio-frequency fields
