


2.3 EUT OPERATING CONDITIONS





Figure C.2 - Boundary of EUT, Local AE and associated cabling





Figure C.2 - Boundary of EUT, Local AE and associated cabling




Figure C.1 - Measurement distance





Figure C.2 - Boundary of EUT, Local AE and associated cabling








Figure C.1 - Measurement distance





Figure C.2 - Boundary of EUT, Local AE and associated cabling





6.5.3 TEST PROCEDURE

The test generator necessary to perform direct and indirect application of discharges to the EUT in the following manner:

a. The test shall be performed with single discharges. On each pre-selected point at least 10single discharges (in the most sensitive polarity) shall be applied.

NOTE 1 The minimum number of discharges applied is depending on the EUT; for products with synchronized circuits the number of discharges should be larger.




