
3.3 EUT OPERATING CONDITIONS

The EUT exercise program used during radiated and/or conducted emission measurement was designed to exercise the various system components in a manner similar to a typical use. The standard test signals and output signal as following:

- 1. EUT Connected to earphone via Audio cable.
- 2. EUT Connected to PC via D-SUB & HDMI & DVI & Audio cable.

4.1.3 TEST PROCEDURE

- a. The measuring distance of 10 m shall be used for measurements. The EUT was placed on the top of a rotating table 0.8 meter above the ground at a 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(below 1GHz).

- c. The height of the equipment or of the substitution antenna shall be 0.8 m, the height of the test antenna shall vary between 1 m to 4 m. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. The initial step in collecting radiated emission data is a receiver peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.






Figure C.2 - Boundary of EUT, Local AE and associated cabling




4.2.3 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.






Figure C.1 - Measurement distance




Figure C.2 - Boundary of EUT, Local AE and associated cabling





Radiated emissions up to 1 GHz










Radiated emissions up to 1 GHz








Radiated emissions above 1 GHz










Electrostatic discharge immunity



Radiated, radio-frequency, electromagnetic field immunity



Surge immunity



Power frequency magnetic field immunity


