- Main board 715G9463 with DisplayPort, HDMI ports, which is supplied by DC output of power board mentioned above;
- The internal metal chassis is considered as fire enclosure and mechanical enclosure, and the external plastic enclosure is regarded as electrical enclosure and mechanical enclosure, made of min. HB material;
- Two internal speakers provided (optional);
- Maximum declared ambient: 40°C.
- The equipment is operated to 5000m sea level as declared by manufacturer.

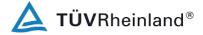


Figure 1. Front view

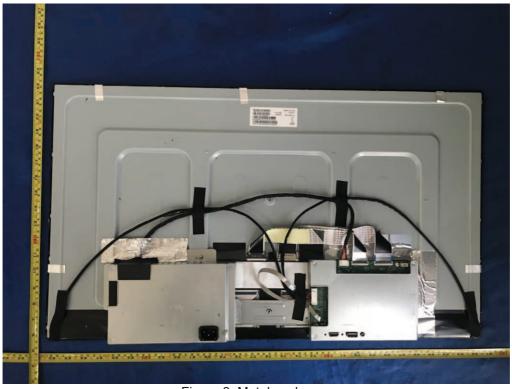


Figure 3. Metal enclosure

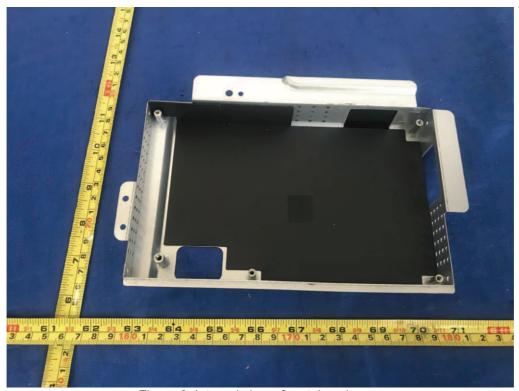


Figure 8. Internal view of metal enclosure

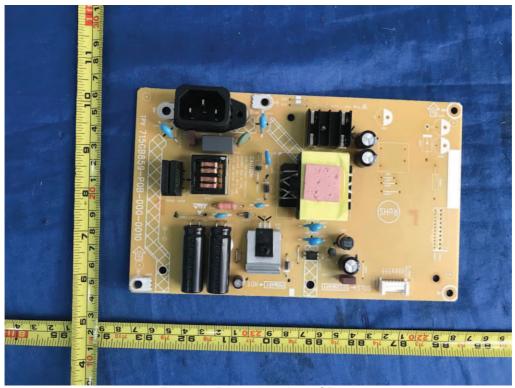


Figure 9. Power board 715GB859
